Per-Unit Taxation Typically, excise taxes are applied on a per-unit basis,<sup>6</sup> rather than as a percentage of the final sale price of the product. For example, cigarettes are currently taxed at \$1.01 per pack<sup>7</sup> at the federal level and \$1.54 per pack<sup>8</sup> on average at the state level.
